## I. SPECIFICATION OF EVENT

The action is focused to exchange and sell of exotic plants, breeding and collectable insects and other invertebrates, terrarium and aquarium animals, collectable products of nature, supplies for breeding and growing, specialist literature and supplementary products with the theme terraristic and aquaristic.

## II. REGISTRATION AND STALLS RENTAL

- II.1.** Vendors are registered through the "Booking system" on the website of the event [www.zivaexotika.cz](http://www.zivaexotika.cz).  
**Vendors without this registration can't participate on the action.**
- II.2.** Anyone who offers for exchange or sell plants, animals, or goods specified in point I.1 (the seller) is obligated to rent retail space. Any manipulation outside these places are prohibited .
- II.3.** The vendor can perform the booking of sales point through the booking system at the address mentioned in Section II.1., or by email [office@zivaexotika.cz](mailto:office@zivaexotika.cz)
- II.4.** The vendor can cancel the the booking by following conditions:
- II.4.1.** 7 days or more before the date of the event - cancellation fee 0% - subscription refunded in full extent.
- II.4.2.** 2-6 days before the event - cancellation fee of 50%
- II.4.3.** 0-1 days before the event - 100% cancellation fee - without entitlement to a refund.
- II.4.4.** The amount of the above mentioned value may be transferred to the vendor's request for a forthcoming event, if it is still available.
- II.5.** The acceptance of booked sales points runs from 7:30 am to 9:45 am. After this time the reservation is forfeited and the place may be offered to another candidate.
- II.6.** **The vendor takes up their selling point personally and he takes full responsibility for all goods and animals offered at the point of sale.** The seller is obliged to inform the organizer, if he give their sales point to other seller.
- II.7.** **At the time from 7:30 to 9:45 pm will be allowed into the exhibition hall only vendors and their assistants, a maximum of 2 persons to each point of sale. Vendors and assistants take up their ID tape personally and affix them to the hand immediately. Entry to the venue of event will be forbid without affixed ID tape.**
- II.8.** The organizer reserves the right to move the vendor to another location if necessary operational and organizational changes.

## III. CONDITIONS OF EXCHANGE AND SALE OF LIVE ANIMALS AND INVERTEBRATES

- III.1.** The animals are transported to the event in accordance with the law č.246 / 1992 Sb. and other related regulations. In particular it must be thermally stable boxes, which are, if necessary, heated in an appropriate manner.
- III.2.** Exchange and sale of animals to the event can take place only under the conditions laid down in this "Rules" and in accordance with applicable laws of the Czech Republic and the EU (b d u h w u f 7 c i b v j f y i u h c b f 0 7 l b c " ' , # + z 5 w i b c % \$ % \$ \$ ( 7 c " z 8 y w y y b c " & % # \$ % 7 c " z z 5 w i b c & \* # / - & 7 c " z 8 y w y y b c " ( % # \$ \$ , 7 c " )
- III.3.** Animals covered by the duty to registration, must be clearly marked "CITES - obligatory registration", in czech "CITES –povinná registrace".
- III.4.** At the latest on the day of the event, the vendor will provide the organizer with a list of the offered species of animals. **The list of poisonous snakes according to point III.10 shall be provided by the vendor at least one week before the event**
- III.5.** Boxes of animals shall be visibly marked with the following information:
- scientific name
  - sex
  - origin
  - CB or WC
  - status of protection
  - size in adulthood
  - food
  - the name of the seller or. firm
- III.6.** Boxes with animals should be placed min. 70 cm above the floor, secured against accidental opening and against falling.
- III.7.** Exhibited boxes must be of an opaque material with a transparent lid, with adequate ventilation, adequate lighted and if necessary heated. Mammals are placed in appropriate boxes or cages.
- III.8. Dimensions of boxes must not be less than:**
- 1.5 times the body length (excluding tail) for reptiles and amphibians,
  - 1/3 of the total length for snakes,
  - 2 times the length of the carapace turtles and tortoises.
- Box height shall be not less than 2 times the height of the body, for arboreal species 3 times. Rodents are placed in boxes so that at least 1/3 of the bottom surface box remained vacant.
- III.9. Animals are placed in boxes singly(except when youngs and feeding rodents) and must have a suitable substrate material (bedding), chameleons with possibility hold to branches and so on. Hygrophilic animals must have suitable wet material, aquatic animals water with an island or land and low water column, not to be forced to constantly swim. Mammals must have suitable bedding, water and food, nocturnal species must have an shelter.**

III.10. Tarantulas, scorpions and centipedes are placed individually

III.11. **The poisonous snakes of the family Viperidae, Crotalidae, Elapidae, Colubridae (genera Philodryas, Thelotornis, Dispholidus and subf. Homalopsinae) and Atractaspididae (genera Atractaspis and Macrelaps) may be offered exclusively in a designated place. After sale, these snakes are safely stored at the seller and are not issued to the buyer until they leave the venue. For this purpose is reserved entrance for vendors. The seller is required to alert the buyer and ensure that this rule is met.**

III.12. The seller can start sale or exchange only after the completion of the inspection of sales points, at the earliest at 9:00 am.

III.13. **At the event is PROHIBITED:**

III.13.1. expose or offer for sale or exchange **animals physically exhausted, sick or suspect disease, pregnant females, hatchlings who are unable to take food itself (including feeding rodents)**

III.13.2. **offering for sale or exchange of live animals to persons under 15 years of age unaccompanied by parents**

III.13.3. **offering for sale or exchange of animals requiring special care (Decree no. 411/2008) to persons under 18 years of age**

III.13.4. **expose or offer for sale or exchange of poisonous snakes somewhere other than the place designated for that purpose and removed these species from boxes for any reason**

III.13.5. exhibit, offer to sell or exchange an animal to an intervention made contrary to the provisions of § 4 paragraph 1 letter g) of Law no. 246/1992.

III.14. Everyone at the event to sell animals requiring special care (Decree no. 411/2008), notifies the buyer of the obligation to register with this animal veterinary administration locally relevant permanent residence.

III.15. If there is a leak of any animal, the animal owner or whoever other immediately inform the organizer.

#### IV. SANCTIONS

IV.1. In case of cancellation by the seller pays the seller a cancellation fee at the rates specified in paragraph II.4. of these Rules.

IV.2. The seller, who break this Rules and / or applicable regulations of Czech Republic, may be dismissed at once or permanently without compensation.

#### V. GENERAL CONDITIONS

V.1. Smoking is strictly prohibited in all places of the hall .

V.2. The organizer is not liable for any damages or losses incurred during the event its participants.

V.3. Everyone is obliged to follow the instructions of the organizers.

V.4. Please keep tidy in all areas of the event and its aftermath, state your selling point in the state in which you accepted.

V.5. Advertising or other promotion can be exclusively under agreement with the organizer.

V.6. Photographing or doing of audiovisual records is possible only with the permission of the organizers.

V.7. These Rules are binding for all.
